## 1. Welcome & Introductions

Paul Gray welcomed new and returning members. He asked if members had other items to add to the agenda. Agenda was approved as circulated.

## **ONGOING ITEMS**

## 2. Upcoming Meeting Dates & Guest Speakers

Members' attention was brought to the chart attached to the Agenda that included meeting dates and times, as well as actual times the rooms were booked.

Paul Gray has contacted Dr. Spray to request a presentation on the findings of the Martian Rover; details have not yet been verified. Luigi Gallo would also be an interesting speaker to address the Japan launch and the X-ray telescope. It was also suggested that March perhaps be a "Members' Night" that could include a guest speaker to address time lapse photography of the moon, and to provide updates and information about (a) upcoming star parties, (b) the Mercury transit, and (c) items that members bring forward.

## 3. Budget

Several items had been identified for discussion.

a) <u>Sale of Dobsonian</u>: Chris Young had circulated a document that included the description of the telescope and its needed repairs; however, it was to be sold as is. The minimum bid would be \$1200.00. Advertisement was to be within the Halifax Centre community; if no bids received it would be extended to a national scope.

b) <u>Outreach</u>: Paul Gray commended Paul Heath for the outreach he has done and thanked him in absentia for the outreach requirements report to Council. It was agreed among members that required literature would be purchased from national (pamphlet + costs, or the related shipping costs to items provided by RASC).

c) <u>Kejimkujik DSW</u>: DSW had already been allotted a budget at the previous meeting for a speaker's travel and accommodations. Dave Chapman commented that the observing field will be better organized this year to ensure the public can be directed to a telescope set up to view a specific night object.

d) Nova East: NE remains self-supporting.

e) <u>Saltscapes / RV Show:</u> Halifax Centre (HC) would not participate at the Sport & RV show this year. However, HC is sharing a table with Atlantic Photo Supply (APS) at Saltscapes (April 22-24).

f) <u>SCO</u>: Tony McGrath provided a draft budget listing the suggested repairs, maintenance and operation and upgrades to SCO. It was agreed that an additional \$200.00 would be allotted to the purchase of a collimator bringing the total budget for SCO Operating and Capital to \$1000.00. Tony would also investigate a heater system for binoculars.

Tony McGrath is to investigate the cost of a heating system for binoculars and provide the information to Jim Millar for budgeting purposes.

g) Nova Notes: Tony Schellinck had previously sent a budget for Nova Notes to Jim Millar.

h) <u>Library</u>: Andy Hasler had pre-circulated a library report to Council members. An inventory of the books in the library had been completed. A budget of \$600.00 had previously been allotted for new book purchases, and the list of potential purchases has been prepared.

i) Star Trek 50th Anniversary: Discussion deferred until June.

j) Nocturne: A budget of \$200.00 is allotted, should funds for this event be required.

k) <u>Secretarial Budget</u>: A budget of \$200.00 will be allotted to cover costs of photocopying and for printing drafts, work and master copies.

l) <u>HalCon</u>: A budget of \$500.00 would be allotted to HalCon (April 4).

m) Geek Quinox: Halifax Centre has been offered a free table (April 23-24).

Because budget allotments for items had not been made prior to this meeting, it was determined that a budget could not be presented at this time. A budget could be prepared for the next meeting.

The document provides a listing of communication activities, responsibilities and timelines for the actions. The document reflects an accurate picture of what currently occurs.

Ian Anderson stated he had brought Nova Notes from the time period of 1999 to April 2013 to the Nova Scotia Archives. It was suggested the RASC minutes also be given to the Archives.

Dave Chapman noted that in the past RASC Halifax Centre had a Facebook page for which Graham Rose was the administrator. Mr. Rose had to step down as the group administrator, and suggested a member of Council be the administrator. Andrew Frank volunteered to assist in that capacity. He also suggested astronomy-related podcasts; this will be discussed at a later meeting.

Paul Gray informed members that New Brunswick was bringing David Levy to Moncton on November 6, 2016, with national RASC paying as part of PSP.
