Item 9. Approval For Beavertbank Site, etc.

-Nat Cohn conveyed that after an initial feeling of sympathy and friendliness a new tone has arisen from the president of the Halifax Flying Club. They will not give us formal access of any type to the field. We are there on sufferance.

-Paul Gray and Jason Adams were in contact with a member of the club who was a member of the RASC Hfx Ctr and he told us that there club needed only to see some sort of liability insurance to show the owner of the land

-Dave Lane suggested we discuss this at the November 19th meeting.

Possibility of an alternate site

-There is a Microwave Tower Hill on the #14 Hiway 8.5km from the Chester turnoff of the 103 headed toward Windsor located on crown land. It is ~40 min from Halifax and has an altitude of 650 ft. To use this as a site for an observatory we would require a government lease which MT&T might already have, but not likely. The best approach would be to talk to Dept. of Lands and Forests and if everything is okay apply for the lease.

Item 10. National Office GA Picture.

Brian Seigal (sp?) sent the Pictures to National Office and said that they didn't want to pay so much for them. The bill will be subtracted from the remittance to National Office.
