The possibility of the Centre being a part of a Mall display planned by TASSC for the 16<sup>th</sup> of March was discussed.

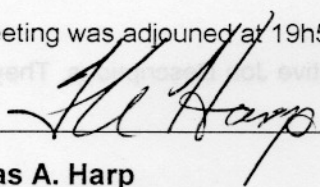
Motion to authorise expenditure of up to \$ 50 for a professionally made, reusable display sign
